## **About the Organization**

At Watershed Management Group (WMG), we envision a world where the relationship between the Sonoran Desert and its people creates prosperity for all. #### **About the Internship**

The River Run Network Restoration and Outreach interns will be part of the WMG team working on the River Run Network (RRN) program, to restore Tucson's heritage of flowing creeks and rivers. They will assist with community outreach, education, and advocacy with the goal of engaging the public in WMG's 50-year vision to restore flow and recruiting and engaging River Run Network members. The RRN intern will help build partnerships and collaborate WMG's Staff on the invasive species removal effort in the Tanque Verde Creek. The intern will support this effort through leading and engaging volunteers during workshops and in the Tucson Community.

WMG is offering two positions for this internship - one focusing more on communications, one focused more on fieldwork. The Duties & Responsibilities outlined below apply to both.

## **Routine Duties & Responsibilities**

- Help with RRN events with a focus on the invasive species removal workshops along the Tanque Verde Creek.
- Promote events through targeted outreach via email, social media, community calendars, and website.
- Attend and co-facilitate 1-3 invasive species removal Saturday morning workshops each month to help engage with members, ensure safety, support staff, take photos, and create blog posts.

- Help with any prep work and clean-up needed
- Assist and co-lead educational components of the workshops
- Assist with engaging students and service groups for this effort
- Reaching out to previous partners & potential groups to present about the project and have them attend workday(s)
- Attend and facilitate 1-2 trash clean up and invasive species removal events each month across the Tucson basin with WMG staff and partners.
- Promote events through targeted outreach via email, social media, community calendars, and website.
- Help engage with members, ensure safety, support staff, take photos, and create blog posts.
- Help with any prep work and clean-up needed
- Assist with engaging students and service groups for this effort
- Reach out to previous partners & potential groups to present about the project and have them attend workday(s)
- Help recruit and engage with new RRN members
- Send out welcome packets to new RRN members
- Attend the River Run Network team meetings and Invasive Species Removal team meetings
