**Job Description:** The Desert Rivers Restoration Manager will be part of WMG's River Run Network program team, leading education, restoration, and community science initiatives. These strategic initiatives support our 50-year goal of restoring flow and ecological function to desert rivers and creeks in the Santa Cruz and San Pedro binational watersheds, with a focus on the greater Tucson area.

Key initiatives include building a community-based movement to value and steward our desert rivers, the restoration of shallow groundwater creek systems in the Tucson basin, and beaver-based restoration to restore wetlands in our binational watersheds.

The Desert Rivers Restoration Manager will also participate in and support strategic development, fundraising, and community outreach efforts to advance WMG's mission.

# **Duties & Responsibilities:**

### **Restoration Initiatives**

- Lead River Run Network watershed restoration project planning, design, and implementation efforts. Duties include conducting site assessments, developing project designs, estimating costs, oversight of contracted crews and volunteers, facilitating community workdays, monitoring, and project administration such as contract/grant management, invoicing, and client management.
- Conduct watershed surveys to identify restoration and stormwater enhanced recharge project opportunities, develop conceptual plans with associated budgets, and coordinate closely with agency and organizational partners.
- Foster community stewardship and scaling of watershed restoration practices including low tech process based and beaver-related riparian restoration.
- Lead/assist grant funding development and partnership development to support restoration priorities.
- Manage project reporting including tracking project metrics, grant reporting, and budget and expense tracking

#### **Community Education & Advocacy Initiatives**

- Lead River Run Network educational activities such as creek walks, invasive species and trash cleanups in creeks and rivers, community events, and educational presentations.
- Be a spokesperson for WMG's River Run Network vision and programs, including giving presentations, attending conferences, and networking with partners.
- Outreach to and engage community members and interest groups in projects and stewardship activities. Engage diverse communities including Latinx, Black, Asian American, and Indigenous communities.

#### **Community Science Initiatives**

- Lead River Run Network Program's annual binational beaver monitoring with Conservation Biology intern. Coordinate and train staff, interns, and volunteer survey leads. Manage survey logistics with partners, including Mexico partners; and oversee data analysis and annual summary report development.
- Work with community members through WMG's Flow365 flow monitoring program. Lead monitoring of private wells in shallow groundwater areas to track seasonal groundwater level trends, connection to surface flows, and overall riparian health.

# **Job Requirements:**

- Interest and support of WMG's mission and vision
- Commitment to diversity, equity, and inclusion and ability to engage with diverse communities and build relationships built on trust and understanding
- 3+ years of experience with community-based conservation, such as education, outreach, and community science
- 5+ years of experience with planning and leading watershed restoration projects such as riparian restoration in arid land watersheds, beaver-based restoration, and erosion control and stormwater enhanced recharge projects
- 2+ years of experience managing staff and/or interns
- 2+ years in grant and contract development and/or management

- Proficiency in MS Office (Word, Excel, and Powerpoint), GoogleDocs/Slides/Sheets
- Excellent interpersonal communication skills
- Accuracy, attention to detail and strong time-management is a must; ability to meet deadlines
- Punctuality and excellent organizational skills
- Ability to work independently outside in physically demanding environments and ability to work well in a team setting
- Experience and interest integrating traditional ecological knowledge and practices into restoration work
- Knowledgeable of environmental issues, especially as related to riparian systems and water resources in arid environments
- Ability to work evening and weekend hours as needed and work outside in physically demanding environments for full field days
