Position Title: Native Edible Tree Project Intern

About the Organization

At Watershed Management Group (WMG), we envision a world where the relationship between the Sonoran Desert and its people creates prosperity for all. This includes all people, plants, animals, land, and waters of the United States, Mexico, and Native American nations found in the Sonoran Desert. Our mission is to develop and implement community-based solutions to ensure the long-term prosperity of people and health of the environment. We provide people with the knowledge, skills, and resources for sustainable livelihoods.

About the Internship

The Native Edible Tree Intern will assist WMG in carrying out a project funded through Arizona State Forestry to explore the use of native edible trees and plants in our region through education and events on urban foraging, cultivating, harvesting and processing of these foods. The intern will assist with logistics and help teach workshops on Sonoran Desert Native Edibles, Workshops on Building Native Food Forests, and Native Edible Kit Distribution events both at the Living Lab and in various Tucson neighborhoods. The position will also provide support for a variety of Community Asset Mapping events to explore opportunities for existing urban foraging, and identify areas where urban food forests could be planted and established. WMG seeks an intern who is able and interested in engaging with limited-income, BIPOC, and LGBTQ+ communities. The intern will need to be available during the week to work with WMG staff and some weekday evenings and Saturdays for community events.

- Most work to be done at WMG's Living Lab, 1137 N. Dodge Blvd, Tucson, AZ with some work in Tucson neighborhoods and at project partner sites
- Work hours Monday Friday, 9am 5pm with some weekend and evening work

Duties & Responsibilities

• Assist with Native Edible Tree programming at the Living Lab, including Family Saturday events, community-centered workshops, and all materials and logistics

associated with these activities

- Assist with participant follow up calls and emails
- Assist with organizing program data into spreadsheets and Asana work management platform
- Assist with scheduling support through the use of Google Calendars and Asana
- Participate in community outreach and engagement to advance WMG's mission
- Assist with Social media support, such as the logistics related to producing hydrolocal video content on Instagram, Youtube, and TikTok.

- Interest in learning about and identifying edible plants native to the Sonoran Desert
- 1+ years of experience in environmental education or community engagement work
